

Charge Policy for Keller ISD

Elementary, Intermediate, Middle Schools, and High Schools:

- Students are allowed to charge up to:
 - **\$25 for Paid Students & \$10 for Reduced Students.**
- Customers are responsible for payment of all charges.
- There is no charging allowed for Ala Carte Items.
- **Adults and Non-Students NO charging allowed.**

Prepayment of Meals:

- Prepayments may be made to your cafeteria account at any time during cafeteria operating hours or you may log onto www.SchoolCafe.com to set up an account for online payments.
- Please contact the Kitchen Manager for any assistance.

******Breakfast and Lunch Programs are designed to serve children. U.S.D.A. Regulations state that NO FOOD is to be taken from the school cafeteria by adults or children.***
